In this regard, attention is drawn towards " Regulation 31A (3)(b)(i), Regulation 31A (3)(b)(ii) and Regulation 31A (3)(b)(iv) which inter-alia states as follows:

"Regulation 31 (A)(3)(b)(i) - the promoter seeking reclassification and persons related to promoter seeking reclassification shall not together, hold more than ten percent of the total voting rights in the listed entity.

Regulation 31 (A)(3)(b)(ii) - the promoter seeking reclassification and persons related to promoter seeking reclassification shall not exercise control over the affairs of the listed company directly or indirectly.

Regulation 31 (A)(3)(b)(iv) - be represented on the board of directors (including not having a nominee director) of the listed entity."

On the basis of the above facts the Company's application and other submissions made in this regard it is observed that the Company is not in compliance with the aforesaid regulations.

In view of the above, the Company's application for Reclassification of Promoters/Promoter Group is rejected
